Exhibitor assumes full responsibility for property damages, personal injury, or death to any party arising from or connected with Exhibitor's participation in the Exhibition and Exhibitor agrees to defend, indemnify and hold harmless ACTS and its agents and employees from all liability which might ensue from any act of God, negligence, product liability, or other cause whatsoever, arising out of or incident to Exhibitor's participation in the Exhibition and not attributed to ACTS. ACTS will not be responsible for property damage or loss, by or for any cause, and Exhibitor hereby waives any right to claim liability against ACTS for the same.

Insurance
